This is just a note to let you know that your protocol, '**Cyclo-oxygenase (COX) inhibitors for threatened miscarriage**' has now been published in *The Cochrane Library* – congratulations! For your information, the full citation for your published protocol (Wariki 2014) is provided below*

Lynn Hampson (our Trials Search Co-ordinator) will run a search of our specialised register, add the search results (references) to the RevMan file for your review, and then contact you to let you know that she has done so, so that you can continue to prepare your review.

Once you receive the search results for your review we recommend that you start to prepare your review as soon as possible in order to avoid your date of search becoming out of date. When a new Cochrane review is published, the date of search should be within one year (ideally within 6 months) in order to comply with the Cochrane Collaboration's Methodological Expectations for Cochrane Intervention Reviews (MECIR). Please note that our Trials Search Co-ordinator will automatically run an updated search for your review six months after her initial search and you may be asked to incorporate the results of the updated search into your review if it has not yet been published in *The Cochrane Library*.
