Great to talk to you. Here is a brief summary of what we discussed on the call. Apologies it has taken over a week to send this summary.

Re: Mass Media Interventions for reducing HIV – We confirmed that:

This review will not be republished through Cochrane as the topic is no longer being actively researched.

Re: Interventions to reduce Stigma – We confirmed that:

- The review is not currently of a high enough quality to be published within the Cochrane library.
- The CIDG editorial group does not currently have the capacity to provide author support to bring the review up to standard.
- If the author team decides to revise the review in the light of the comments below, and resubmit to Cochrane, there will still be no guarantee that it will be accepted for publication.

The following are suggestions for how to improve the Stigma review. These are the things we discussed, and it is not an exhaustive list of what needs to be done:

Logic Framework – We discussed the draft model suggested by DS. This is only a draft and needs further work from the authors. However, this diagram demonstrated one important factor which should influence the whole structure of 1. the review: There are two target groups for interventions to reduce stigma:

People without HIV (the general population and sub-populations such as children, health workers etc) – e.g. Educational interventions might aim to improve knowledge about HIV and change attitudes towards people with a. HIV

People with HIV - e.g. Interventions might aim to reduce the consequence of stigma, or improve a persons ability to cope with it. b.

These are two different questions, and the review currently includes both.

2. Characteristics of included studies - It would be useful to have two additional tables. One table clearly describing the interventions in trials targeting people without HIV (point 1a above), and one clearly describing the interventions in trials targeting people with HIV (point 1b above). These tables help you decide which trials can be combined in a meta-analysis. Currently in the review, there are almost no meta-analyses. This is understandable given the variation in interventions, populations, and outcomes measured, but if the trials are clearly described in this way it should be possible to combine some of the trials

Outcomes - Using examples from the review called 'psychosocial group intervention' - we discussed the importance of understanding the different scales used to measure outcomes (such as the Coping Self-3. efficacy scale). It is important to have a table describing how each scale is measured and how the result should be interpreted. Where different scales are measuring roughly the same thing, they can be combined in meta-analyses using the standardised mean difference.
