Overall recommendation: Publishable with minor revisions.
Experts comments:

- The Introduction does not describe the objectives and results of the **study**; it is necessary to revise it in order to describe the aims of the paper, methodology and preliminary results;
- The Keywords are missing;
- The Literature review part could be expanded/revise and it has to explain how this article is different from other studies and concur to existing knowledge;
- The Conclusions section must be revised to make it more complete and relevant.
- The Keywords should not repeat words from the title and it should not be phrases (as a rule).
- The text of the article should be correctly structured (for example, the introduction and the Literature Review are two separate sections, not as now when the Literature Review is part of the Introduction).
- It's better to remove the table 1.1 and present this information from Table 1.1 as text with a reference to the original source.
- Revise the text of section 2.2 and 2.3, in order to avoid similarities with papers of other authors.

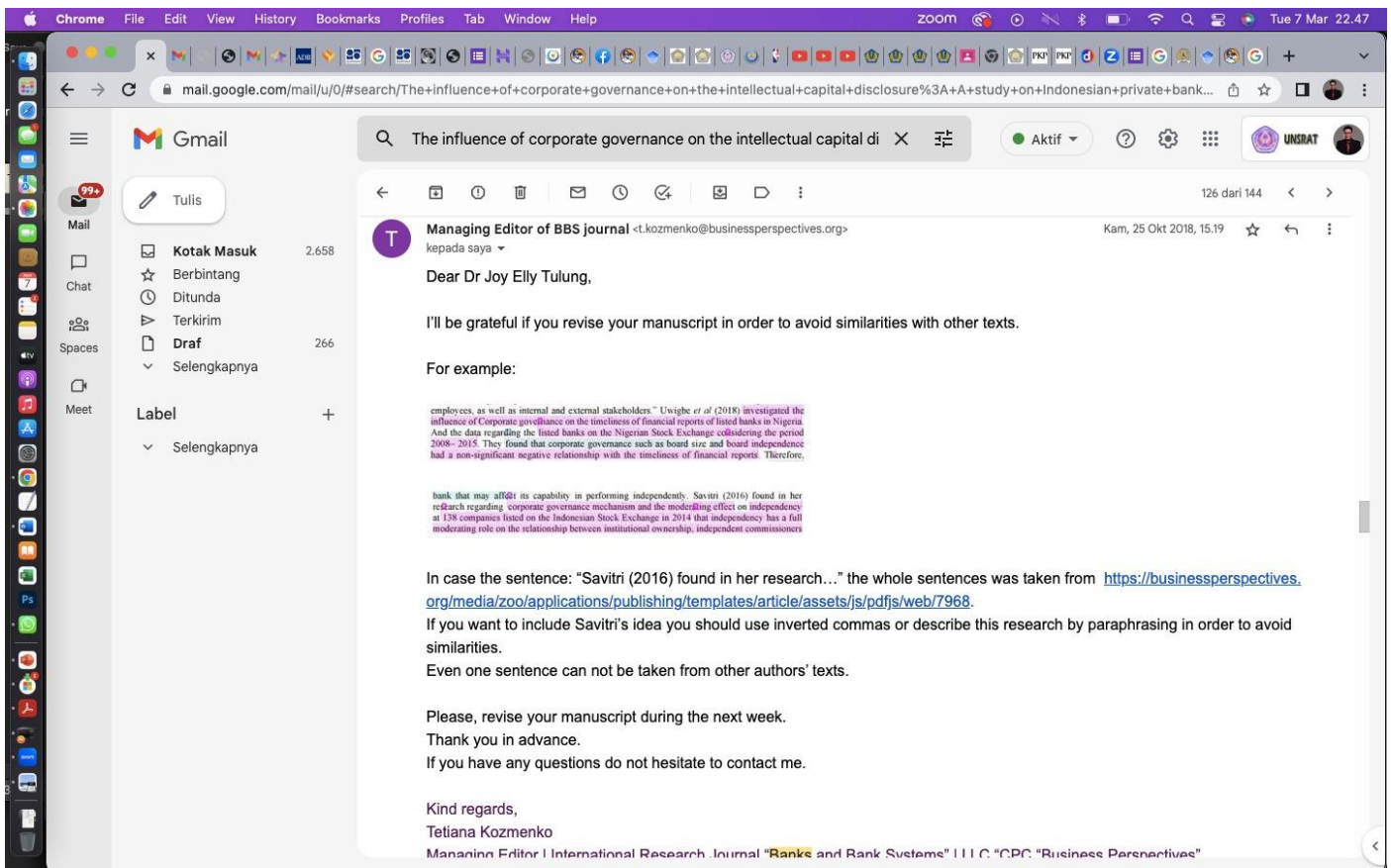
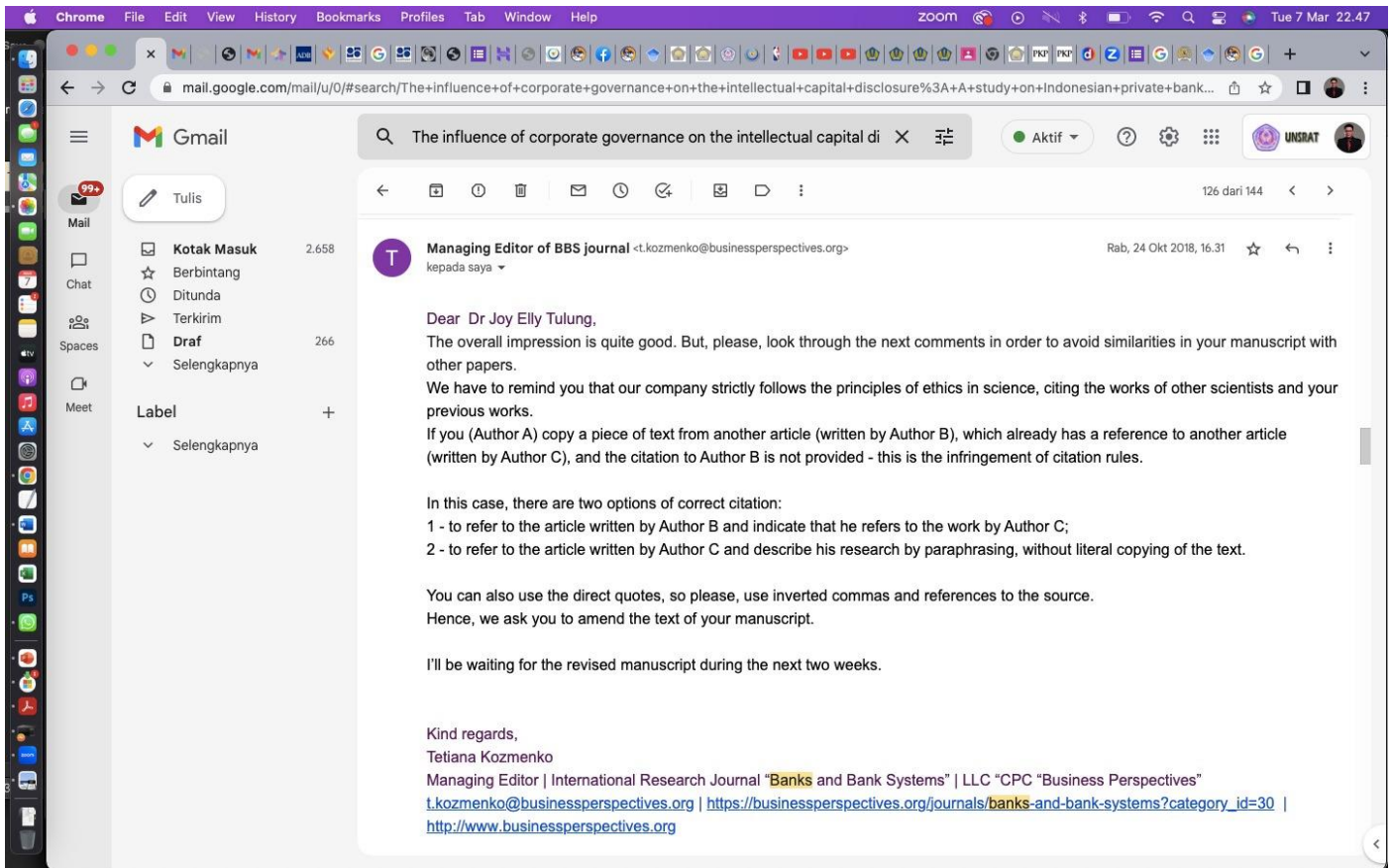


